OUTDOOR SEATING

FROM BOSTON'S ETS REGULATION (12/08)

Work space or work spaces: any enclosed indoor and adjacent outdoor area, structure or facility occupied by an employee during the course of his or her employment, including but not limited to: offices; customer service areas; common areas; patios/porches; decks; yards; loading docks; hallways; waiting areas; restrooms; lounges; and eating areas. (Pop.: 636,479)

Smoking shall be prohibited in the workplace. This includes all work spaces, common work areas, auditoriums, classrooms, conference and meeting rooms, private offices, elevators, hallways, medical facilities, cafeterias, employee lounges, staircases, restrooms, patios, decks, yards and loading docks.

FROM LYNN'S ETS REGULATION Outdoor Seating: Any outside area of an establishment that is under the control or management of said establishment. -- Smoking is prohibited in all workplaces, all public places, outdoor seating (as described under definitions), private social functions and private clubs. (Andover, Arlington, Ayer, Bedford, Billerica, Hingham, Lexington, Middleton, Milton, Sherborn) (9 - Pop.: 329,012)

FROM NEWBURYPORT'S ETS REGULATION Smoking shall be prohibited in all outdoor areas of restaurants, bars, taverns, and any other outdoor place where food, and/or alcoholic beverages, and/or non-alcoholic beverages are sold to the public and served to the public, or otherwise consumed or carried by the public. (Charlemont, East Longmeadow, Fitchburg, Granby, Greenfield, Holbrook, Hudson, Lawrence, Leverett, Ludlow, Medway, Methuen, North Andover, Northboro, Orleans, Provincetown, Somerville, South Hadley, Southampton, Whately, Winthrop) (21 - Pop.: 464,296)

FROM EASTHAMPTON'S ETS REGULATION No person shall smoke, nor shall any person or employer or other person having control of the premises upon which smoking is regulated by this regulation, or the business agent or designee of such person, permit a person to smoke in any of the following places as defined herein: workplaces, public places, private clubs, restaurants and bars, including outdoor seating of a restaurant or bar; educational facilities, indoor sports arenas, health care facilities, hotels, and public transportation, except as otherwise provided in Section 7.6 of this regulation. [Bourne, Martha's Vineyard] (7 - Pop.: 52,726)

FROM AMHERST REGULATION In addition to the prohibitions contained in M.G.L. Ch. 270, §22, M.G.L. Ch. 111, §31 and M.G.L. Ch. 270, §22(j) smoking is also hereby prohibited: . . . in all outdoor areas where food and/or beverages are served to the public by employees of restaurants, bars and taverns [Adams, Agawam, Belchertown, Beverly, Brewster, Gill, Hadley, Hamilton, Hatfield, Holden, Holyoke, Marlborough, Medfield, Milford, North Reading, Rockport, Royalston, Provincetown, Sutton, Tyngsborough, Uxbridge, Wareham, Westford, Winchester, Winthrop] (25 - Pop.: 464,493)
