What is the Solid Waste Master Plan?

- Big picture plan for how we will manage our trash
- Prioritizes meeting waste disposal need by reducing disposal
- Current plan published in October 2021
- This plan runs through 2030

Where does our trash go?

- In state disposal about 3.9 million tons
 - 5 Municipal waste combustors 3 million tons
 - 5 Landfills 900,000 tons
- Out of state disposal (net) about 1.6 million tons
 - More than 200 waste transfer stations
 - Increase in rail-based transfer
 - Receiving states include
 - Ohio
 - New Hampshire
 - New York
 - South Carolina

What are our waste reduction goals?

- Ensure adequate capacity to manage our waste
 - Preferred option to reduce the amount of waste disposed
 - Capacity limitations will affect disposal cost
- Reduce disposal by 30% by 2030
- Reduce disposal by 90% by 2050
- Enhance engagement with Environmental Justice communities throughout our programs

Solid Waste Master Plan Capacity Issues

- Primary Focus reduce disposal through waste reduction and diversion
 - SWMP disposal reduction goals & programs
 - Reduce & Reuse Action Plan
 - Market Development Plan
 - Expanded waste bans
- Waste to energy capacity
 - Up to 350,000 TPY alternative WTE capacity
 - Replacement municipal waste combustor capacity
- Permitting of landfill capacity

Waste Ban History & Background

- First waste bans promulgated in early 1990s
- Done via regulation under statutory authority
- "No person shall dispose, transfer for disposal, or contract for disposal or transport of the restricted material..."

Waste Ban Approach

- Develop and implement new waste bans over period of several years
- Combine with technical assistance, education and outreach, and market development initiatives
- Focus on compliance by larger generators businesses and institutions
- New bans emphasize compliance assistance initially

Waste Ban Implementation

- Inspections, Compliance & Enforcement
 - Solid waste facilities required to maintain and implement waste ban compliance plans
 - MassDEP conducts inspections at solid waste facilities
 - Issue enforcement when observe loads with significant amounts of a banned material
 - Typically, only enforcement against business, institutional, or government generators or waste haulers
 - Not residents

New Waste Disposal Bans

- Effective date of new bans November 1, 2022
- Mattresses, textiles and reduced food waste threshold (from 1 ton to ½ ton per week)

Why are these new waste bans important?

- Need to ensure adequate capacity to manage our waste
 - Preferred option is to reduce the amount of waste disposed
 - Disposal capacity limitations will affect disposal cost
- Solid Waste Master Plan Goals
 - Reduce disposal by 30% by 2030
 - Reduce disposal by 90% by 2050
- Secondary Benefit
 - Support local economic and job growth through increased reuse and recycling

Solid Waste Facility Requirements

- If done not already, need to update waste ban plan and submit to MassDEP
 - This was due August 1, 2022
 - If transfer station (not C&D) only required to submit certification form

- Waste ban web pages updated, includes:
 - Solid waste facility guidance and sample forms
 - Third party inspection forms

Food Waste Ban

- Food waste largest portion of MSW about 1/5th
- Will add about 2,000 entities restaurants are the sector with the largest increase
- May affect about 30 largest public schools, RecyclingWorks Food Waste Estimator Tool

How can my Business Comply?

- Compliance standard is to dispose of <1/2 ton per week of food waste
- Can comply through any combination of:
 - waste reduction/prevention
 - Food rescue and donation
 - On-site systems
 - Sending food waste to animal feed, compost, or anaerobic digestion
- If comply with the 1 ton per week ban, may need to take further reduction/diversion steps now

Textiles

- Clothing, linens, towels, bags, other fabric
- Dispose about 26oK tons/year about 5% of trash
- All types of textiles must be clean and dry

- If wet, moldy, or oil, not subject to waste bans and should be disposed of in the trash

Mattresses

- About 600K mattresses/year about 200K residential
- All size mattresses and box springs
- Includes foam mattresses
- Only 1-2% of mattresses not recyclable
- In-state capacity 46oK/year and growing
- Difficult to manage in solid waste most solid waste facilities charge mattress fees at or above recycling cost
- State mattress recycling contract FAC 90

Contaminated Mattress Management

- If wet, moldy, or infested with bed bugs, document the number of mattresses, condition of each, and how stored and managed to prevent contamination.
- Not acceptable to store mattresses uncovered outside and then send for disposal because they are wet. Intentional contamination of waste ban materials is considered a waste ban violation.

Documentation Needed to Send for Disposal

- As long as materials stored & managed properly & documentation is maintained and provided to MassDEP upon request, unrecyclable mattresses can be sent for disposal without requiring a MassDEP waste ban waiver.
- MassDEP Contaminated Mattress Certification Form
 - Provides documentation to solid waste hauler or facility that OK to accept a mattress for disposal

Waste Ban Waivers

- MassDEP can approve waivers to allow the one-time or temporary disposal of waste ban materials
- Either issue as one-time approvals or short term (up to 1 year) if no alternatives to disposal
 - May be contaminated or otherwise nonrecoverable/recyclable material
- Can request and issue via email
